Oregon Aero® BLU® Kit Ballistic Helmet Liner Upgrade Kit

Kit contains one round crown pad, four oval pads, two trapezoidal pads and self-adhesive hook-and-loop fastener strips.

Installation Instructions

- 1. Remove the original suspension system from your helmet. Be sure and save all screws and nuts.
- 2. Clean inner surface of helmet with rubbing alcohol.
- 3. Attach self-adhesive hook-and-loop strips to inner surface positions indicated in **Figure 1**.
- 4. Install the seven helmet pads. Only the green side of each pad will adhere to the hook-and-loop fastening strips. The larger, round pad attaches to the crown of the helmet. The two trapezoidal pads attach to the front and back of the helmet. The narrow end of the trapezoidal pads should point toward the crown of the helmet. Attach the four oval pads lengthwise to the hook-and-loop fastening strips on the sides of the helmet. Refer to Figure 2 for positioning the pads.
- 5. Re-install the original chin/nape system using all screws and nuts.
- 6. Place the straps for the camo cover over the hook-and-loop fastening strips to hold the camo cover secure and attach the pads over the camo cover straps and hook-and-loop fastener.

Please Note: In cold environments use hands or place helmet on your knee to pre-warm pads.

Washing the Pads

Wash pads by hand with a solution of mild soap and water. Rinse pads completely, lay flat, and allow to air dry. Never put your pads in a clothes dryer.

If you are not satisfied with your Oregon Aero product for any reason, you have 30 calendar days to return the product from the date you purchased it for a full refund or exchange. To be eligible, product must be in good condition and include the receipt.
